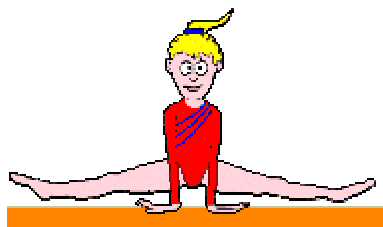
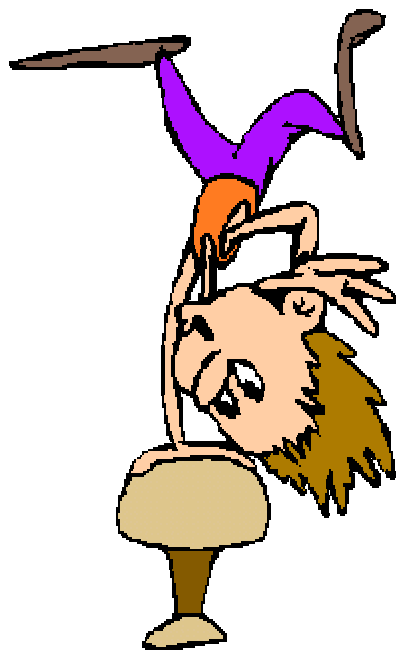

If you are part of the Late Pick Up program and you arrive later than 6:15 p.m. there will be a strictly enforced \$10.00 charge for every 15 minutes starting at 5:15 p.m. until pick up.

Check In And Out Procedures

It is required that your child be SIGNED IN & OUT each day. In the morning, please sign your child In, at the front desk. Your child may then enter the gym and join their group. If another adult other than a parent or legal guardian is picking up, we require that they be an authorized person listed on your child's registration form. Any deviation from routine pickup or persons not listed on the registration form (i.e., a visiting relative, friend, etc.) must be indicated in writing by the parent or legal guardian and given to administrative staff at the front desk so that we can communicate this to the appropriate day camp counselor. Please make sure that anyone picking up your child has ID with them. Your cooperation concerning this procedure will help ensure the safety of your child.

PAYMENT POLICIES / TERMS

The camp fees listed on the previous page are for advance reservations. In order to take advantage of these rates, we require a 5 business day notice to make any changes to your reservations. If this is not received, a drop in fee of \$45 per day will be charged. If you drop-in on a field trip day, there will be an additional charge for the trip. You may transfer reserved weeks if we are given a 5 business day notice and subject to availability. If we are not notified 5 business days in advance, you will be charged for your reservation. If you are reserving two weeks of camp or less, payment for all reserved dates are due upon registration. If you are reserving more than two weeks, we require payment in advance for your first week at registration in addition to a one week deposit to be held as payment for your last week's attendance at camp. The deposit collected is **NON-REFUNDABLE** and **MUST** be applied toward your final weeks' reservation. If you choose not to have your child attend the last week **YOU** reserved and designated as their final week of camp on your registration form, **YOUR DEPOSIT WILL NOT BE REFUNDED**.

All reservations over two weeks will **REQUIRE** a Guaranteed Form of Payment to be kept on file in the form of a credit card. Your credit card will always be charged on the Thursday prior to your subsequent week's reservation. If you wish to pay by check or cash, payment must be received by the Wednesday preceding your reservation or your credit card will be charged. **ABSOLUTELY NO EXCEPTIONS WILL BE MADE** and **NO REFUNDS** will be given for missed days/weeks or cancellations. Coral Reef accepts Visa and MasterCard.
